Dear Parent/Guardian:

We regret to inform you that your child has failed the subject(s) listed below. Failure to attend or participate in summer school could alter their 2019-20 schedule and their eligibility to participate in athletics. A student must pass a minimum of 30 credits during the 2018-19 school year (summer 2019 included) to participate in athletics. However, if your child's grade has fallen below a **50** he/she is not eligible to attend summer school for credit recovery. A student with grade below 50 that wants to take a course online would have to take a full course for credit (more time and money on Educere – online).

The guidance department is recommending students either attend summer school at Clifton, Bogota, Bergen Community or online through Educere. For this option, students must be well organized with their time and with submitting work electronically in order to be successful. If you should have any questions, please call the guidance office. You can find summer school registration information at [www.bectonhs.org](http://www.bectonhs.org). You must complete Becton's credit recovery registration form and have it signed by your counselor before you can register for summer school. Please be aware of summer school registration dates. For Educere, students must register no later than **July 1<sup>st</sup>, 2019**.

## CREDIT RECOVERY / SUMMER SCHOOL FORM

High school students who have failed a course may wish to consider summer school for credit recovery to remain on track for graduation and/or to avoid repeating a full – year course the next school year.

Students can register at a traditional summer school or online. Online courses may only be taken with the approved online provider, **Educere**. Students may take a maximum of three (3) courses for credit recovery each summer (combination of online or at a traditional summer school). The student or parent/guardian is responsible for all course fees. Students with a grade below **50** are not permitted to take summer school.

**REQUIRED APPROVAL:** Approval from the school counselor or a high school administrator (if the counselor is not available) is required prior to registration. If a student registers for a course without prior authorization, he/she may not receive credits and will not be reimbursed for payments made to Educere or the traditional summer school they are attending for credit recovery. Authorization is complete once the counselor approves the courses that may be taken.

**Students must register no later than 7/1/19 for Educere and be completed no later than 8/16/19.**

**For traditional summer school, please be aware of registration deadlines.**
